Hamilton Township Planning Commission

Regular Meeting Minutes 1/16/2024

The meeting was called to order at 7:00 PM by Chairman Mel Lebo.

Members Present: Mel Lebo, Ira Bitner, Ronald L. Weidner, Lela Reichart, and Christine Myers.

Also Present: Zoning Officer James Graham

Reorganization: Ronald L. Weidner motioned to maintain the current positions: Mel Lebo as chairman and Ira Bitner as Vice Chair, seconded by Ira Bitner. **The motion carried unanimously.**

Motion to Adopt the Agenda: Ronald L. Weidner made a motion to approve the agenda, seconded by Ira Bitner. **The motion carried unanimously.**

<u>Minutes</u>: The regular meeting minutes of December 19, 2023, were presented for approval. *Christine Myers made a motion to approve the minutes with a second by Ronald L. Weidner. The motion carried unanimously.*

New Business:

Neff's Trucking – 1113 Route 194 N: The board discussed Neff's Trucking's request for a zoning exception, considering compliance issues and setting approval conditions. They agreed to recommend the Zoning Officer to represent the Township at the Zoning Hearing Board. A proposal was made to draft a letter to the Zoning Officer, recommending the Zoning Hearing Board grant a special exception with conditions for operating a trucking business at 1113 Route 194 N due to the township's acceptance of a prior non-conformance. The conditions outlined were: 1) Compliance with land development and stormwater management requirements by Adams County Conservation District and Hamilton Township Engineer, and 2) Adherence to Zoning Ordinance 150-98DD.

Old Business:

- <u>Little Life Enrichment Stormwater Management:</u> A motion to table the discussion was proposed by Ronald L. Weidner with a second by Ira Bitner. **The motion carried unanimously.**
- Minor Subdivision Herman/Klein: Discussions involved the Planning Commission for Hamilton Township recommending that the Board of Supervisors grant conditional approval for the Minor Subdivision of the Herman/Klein property. This approval is contingent upon satisfying all conditions outlined by the Township Engineer and the Adams County Office of Planning & Development, ensuring compliance with township zoning and planning standards. Ronald L. Weidner made a motion to recommend conditional approval of the Herman/Klein minor subdivision application with a second by Lela Reichart. The motion carried unanimously.
- <u>K-Hill Enterprises:</u> A motion to table the discussion was proposed by Ronald L. Weidner with a second by Ira Bitner. *The motion carried unanimously.*

- <u>Cross Keys Intersection:</u> Several members attended the kickoff meeting for the advisory group last week, currently in the information-gathering phase. A more detailed update is anticipated next month. A motion to table the discussion was proposed by Ronald L. Weidner with a second by Ira Bitner. The motion carried unanimously.

- New Oxford Logistics LLC-Zoning Hearing Board Request: A motion to table the discussion was proposed by Ronald L. Weidner with a second by Ira Bitner. The motion carried unanimously.
- Ordinance Amendment Status / Completion
 - <u>AP-RR</u>: Mel Lebo collaborated with Megan to update the Ordinance Tracker. The Lighting Ordinance has already been submitted to General Code. The following items are being prepared for submission:
 - Truck Terminal (Section 150-98 DD)
 - o Revised Stormwater Management Plan
 - Self-Storage (Section 150-98 AA)

Additionally, Megan will advertise a public hearing for the AP-RR Ordinance during the Board of Supervisors meeting on February 5th, with the potential for approval that night. Once the AP-RR Ordinance is approved, it, along with the other items, will be ready for submission to General Code, bundled to optimize fee savings.
