The Board of Supervisors of Hamilton Township, Adams County, Pennsylvania resolves to add certain zoning permit fees, license fees and event fees to the existing Hamilton Township Fee Schedule and it shall be resolved that the following fees shall become effective beginning January 2, 2024.

The following fees shall be added to the 2024 fee schedule for Hamilton Township, Adams County, Pennsylvania.

\$100.00 Public Event plus any additional cost for any expenses incurred by the Township for this event. Non-Profit organizations bearing exemption 501.3c on application are exempt from permit fee but will incur cost for any expenses incurred by the Township for this event.

\$100.00 annual permit fee Agri Tourism (all)(§150-98)

\$500.00 Bed & Breakfast Inn (§150-98) annual license and inspection fee.
